TRAIL INITIATIVE, SHOULD STATE PAUL BUNYAN TRAIL-COUNTY ROAD 16 CROSSING, NOT LILAC STREET, AND RESOLUTION 26-05-341 ADDITION TO AGENDA ITEM 6A.

BID TABULATION

BIDS FOR THE 2026 VETERANS STREET IMPROVEMENT PROJECT WERE OPENED ON MAY 5, 2026 AT 10:00 AM. FOUR BIDS WERE RECEIVED, AS FOLLOWS:

- ANDERSON BROTHERS CONSTRUCTION COMPANY OF BRAINERD, LLC — \$199,297.23
- NORTHERN PAVING, INC., BEMIDJI — \$216,720.00
- IDEAL CONSTRUCTION, STEVEN F. KOBLISKA & SONS, LLC, STAPLES — \$230,995.30
- WESTIN PROPERTY DEVELOPMENT, PEQUOT LAKES — \$252,000.00

THE ENGINEER'S ESTIMATE FOR THE PROJECT WAS \$268,417.50. A MINOR MATHEMATICAL ERROR WAS IDENTIFIED IN WESTIN PROPERTY DEVELOPMENT'S BID, THOUGH IT DID NOT AFFECT THE LOW-BIDDER DETERMINATION.

ENGINEER'S RECOMMENDATION

THE CITY'S ENGINEERING FIRM, WIDSETH SMITH NOLTING & ASSOC., INC., RECOMMENDED AWARDING THE CONTRACT TO ANDERSON BROTHERS CONSTRUCTION COMPANY OF BRAINERD, LLC, AS THE LOWEST RESPONSIBLE BIDDER, BASED ON UNIT PRICES IN ITS BID PROPOSAL.

MOTION TO AWARD THE 2026 VETERANS STREET IMPROVEMENT PROJECT CONTRACT TO ANDERSON BROTHERS CONSTRUCTION COMPANY OF BRAINERD, LLC IN THE AMOUNT OF \$199,297.23 WAS MADE BY FLATEGRAFF AND SECONDED BY SILTMAN. MOTION CARRIED.

NORTHLAND COMPANIES CUP AMENDMENT

THE COUNCIL CONSIDERED THE PLANNING COMMISSION'S RECOMMENDATION TO APPROVE A CONDITIONAL USE PERMIT (CUP) AMENDMENT FOR NORTHLAND COMPANIES OF CROW WING COUNTY (APPLICANT: NATHAN LANGE) FOR PROPERTY LOCATED AT 3691 POULAK STREET. THE AMENDED CUP WOULD ALLOW A MULTI-TENANT COMMERCIAL PROPERTY, INCLUDING CONTRACTOR-TYPE BUSINESSES FOR LANDSCAPING SUPPLY, INSULATION, AND AUTO DETAILING, WITH ASSOCIATED OUTDOOR STORAGE AND OPERATIONAL ACTIVITIES IN THE C-2 ZONING DISTRICT.

THE SUBJECT PROPERTY WAS ORIGINALLY GRANTED A CUP ON DECEMBER 13, 2021, FOR COMMERCIAL USE. SINCE THAT TIME, THE CITY IDENTIFIED CHANGES IN THE USE AND INTENSITY OF THE PROPERTY NOT REFLECTED IN THE ORIGINAL PERMIT. THE CITY REQUESTED AN AMENDED CUP APPLICATION BEGINNING IN JUNE 2025, WITH ONGOING COMMUNICATION THROUGH EARLY 2026 TO ADDRESS OUTSTANDING COMPLIANCE ITEMS INCLUDING PERMITTING, SSTS VERIFICATION, CLARIFICATION OF SITE USES, AND SITE-RELATED COMPLIANCE MATTERS.

THE PLANNING COMMISSION HELD A PUBLIC HEARING ON MAY 4, 2026 AND RECOMMENDED APPROVAL SUBJECT TO CONDITIONS. THE PUBLIC HEARING BEFORE THE PLANNING COMMISSION INCLUDED TESTIMONY FROM THE APPLICANT REGARDING ON-SITE ACTIVITIES, ONGOING CLEANUP, NEIGHBORING PROPERTY MAINTENANCE, AND THE NATURE OF BUSINESS OPERATIONS. DURING DELIBERATION, THE COMMISSION DISCUSSED THE OUTDOOR STORAGE AND SCREENING CONDITION. THE ORIGINAL DRAFT CONDITION REQUIRED THAT OUTDOOR STORAGE BE "FULLY SCREENED"; HOWEVER, THE COMMISSION DETERMINED THIS LANGUAGE WAS OVERBROAD GIVEN THE RECENTLY AMENDED HIGHWAY BUSINESS DISTRICT SCREENING ORDINANCE (O-26-50). THE WORD "FULLY" WAS STRICKEN, AND THE CONDITION WAS REVISED TO REQUIRE THAT OUTDOOR STORAGE BE ORDERLY AND SCREENED PER ORDINANCE STANDARDS APPLICABLE TO RESIDENTIAL ADJACENCY.

THE COMMISSION FURTHER DISCUSSED THE APPLICANT'S REQUEST TO WAIVE THE \$500 APPLICATION FEE, CITING THAT THE ORIGINAL CUP HAD NOT BEEN PROPERLY DOCUMENTED AT THE TIME IT WAS FIRST ISSUED. SOME MEMBERS ACKNOWLEDGED THAT WHILE THERE WERE DOCUMENTATION DEFICIENCIES ON THE CITY'S PART, THERE WERE ALSO COMPLIANCE ITEMS ON THE APPLICANT'S SIDE THAT HAD NOT BEEN ADDRESSED DURING THE FIVE YEARS SINCE THE ORIGINAL CUP. THE COMMISSION REACHED A CONSENSUS TO RECOMMEND A PARTIAL FEE TO THE CITY COUNCIL, MEETING IN THE MIDDLE AT \$250.

THE COUNCIL CONSIDERED RESOLUTION 26-05-340, APPROVING THE CUP AMENDMENT BASED UPON THE PLANNING COMMISSION'S RECOMMENDATION AND THE FINDINGS OF FACT AS SET FORTH IN THE RESOLUTION, SUBJECT TO THE FOLLOWING CONDITIONS OF APPROVAL:

1. **SITE PLAN:** THE PROPERTY SHALL MAINTAIN AN APPROVED SITE PLAN (USES, PARKING, STORAGE, SCREENING). NO CHANGES WITHOUT CITY APPROVAL.
2. **ALLOWED USES:** ONLY C-2 COMPATIBLE COMMERCIAL/SERVICE USES ALLOWED. CHANGES IN USE OR INTENSITY REQUIRE CITY REVIEW.
3. **OUTDOOR STORAGE & SCREENING:** OUTDOOR STORAGE IS LIMITED TO DESIGNATED AREAS AND SHALL BE ORDERLY. NO JUNK, DEBRIS, OR INOPERABLE VEHICLES.
4. **PARKING & ACCESS:** OFF-STREET PARKING AND SAFE CIRCULATION REQUIRED. COMMERCIAL VEHICLES LIMITED TO APPROVED AREAS. NO ON-STREET OR AISLE PARKING.

5. **PERFORMANCE STANDARDS:** ALL USES MUST MEET CITY STANDARDS FOR NOISE, ODOR, DUST, LIGHTING, AND DRAINAGE.
6. **FLOOR DRAINS & WASTEWATER:** NO DISCHARGE TO GROUND, STORMWATER, OR SEPTIC SYSTEMS. WASTEWATER MUST DISCHARGE TO SANITARY SEWER OR A COMPLIANT HOLDING TANK.
7. **HOLDING TANK & WASTE DISPOSAL:** HOLDING TANKS MUST BE MAINTAINED AND PUMPED AT APPROVED FACILITIES. ALL WASTES MUST BE PROPERLY MANAGED PER MPCA REQUIREMENTS.
8. **OPERATIONAL PRACTICES:** TENANTS SHALL FOLLOW MPCA BEST PRACTICES.
9. **OWNER RESPONSIBILITY:** PROPERTY OWNER IS RESPONSIBLE FOR TENANT COMPLIANCE AND SITE MAINTENANCE.

MOTION TO ADOPT RESOLUTION 26-05-340 APPROVING THE CONDITIONAL USE PERMIT AMENDMENT FOR NORTHLAND COMPANIES OF CROW WING COUNTY, SITING FINDINGS OF FACT AND SUBJECT TO THE CONDITIONS OF APPROVAL AS STATED, WAS MADE BY SILTMAN AND SECONDED BY BARNETT. FLATEGRAFF ABSTAINED. MOTION CARRIED.

MOTION TO REDUCE THE CUP APPLICATION FEE TO \$250.00 WAS MADE BY SILTMAN AND SECONDED BY BARNETT. FLATEGRAFF ABSTAINED. MOTION CARRIED.

PROPOSED ORDINANCE AMENDMENT O-26-50 HIGHWAY BUSINESS DISTRICT SCREENING REQUIREMENTS

THE COUNCIL CONSIDERED ORDINANCE AMENDMENT O-26-50, WHICH AMENDS SECTION 150.033 OF THE JENKINS CITY CODE OF ORDINANCES RELATED TO SCREENING PERFORMANCE STANDARDS IN THE HIGHWAY BUSINESS (C-2) ZONING DISTRICT. THE PLANNING COMMISSION PREVIOUSLY HELD A PUBLIC HEARING AND RECOMMENDED APPROVAL. THE AMENDMENT REPLACES PRESCRIPTIVE SCREENING LANGUAGE REQUIRING 100% SCREENING TO ADJACENT RESIDENTIAL PARCELS AND OVER 50% SCREENING FROM THE ROAD OR ANY NON-RESIDENTIAL PARCEL WITH MORE FLEXIBLE LANGUAGE ALLOWING THE PLANNING COMMISSION TO IMPOSE SITE-SPECIFIC SCREENING CONDITIONS ON INDIVIDUAL CUP APPLICATIONS. THE NEW LANGUAGE ALLOWS SCREENING TO BE REQUIRED AS A CONDITION OF CUP APPROVAL WHERE NECESSARY TO MITIGATE VISUAL, NOISE, OR OPERATIONAL IMPACTS, DETERMINED ON A CASE-BY-CASE BASIS REASONABLY RELATED TO THE NATURE OF THE PROPOSED USE, SITE CONDITIONS, AND SURROUNDING LAND USES.

MOTION TO ADOPT ORDINANCE NO. O-26-50 AMENDING THE HIGHWAY BUSINESS DISTRICT SCREENING STANDARDS WAS MADE BY SILTMAN AND SECONDED BY FLATEGRAFF. MOTION CARRIED.

AUDITING/ACCOUNTING SERVICES

CLA AUP ENGAGEMENT PROPOSAL

THE COUNCIL REVIEWED THE AGREED-UPON PROCEDURES ENGAGEMENT PROPOSAL SUBMITTED BY CLIFTON LARSON ALLEN LLP (CLA), DATED MARCH 19, 2026, AT AN ESTIMATED FEE OF \$10,500 (\$10,000 FOR THE AUDIT AND \$500 FOR THE TECHNOLOGY AND SUPPORT FEE).

ABDO AUP ENGAGEMENT PROPOSAL

THE COUNCIL ALSO REVIEWED THE AGREED-UPON PROCEDURES ENGAGEMENT PROPOSAL FROM ABDO, DATED MAY 5, 2026, AT AN ESTIMATED FEE OF \$9,000. ABDO INDICATED WORK WOULD BEGIN APPROXIMATELY JUNE 1, 2026, WITH COMPLETION BY AUGUST 1, 2026.

MOTION TO SELECT AN AUDITING/ACCOUNTING FIRM AND AUTHORIZE THE CITY CLERK-TREASURER TO PROCEED WITH THE ENGAGEMENT WAS MADE BY MAYOR RUDLANG AND SECONDED BY SILTMAN. MOTION CARRIED.

ROADWAY CONCERNS

SCHRUPP EXCAVATING ESTIMATE

THE COUNCIL REVIEWED A ROADWAY CONDITIONS REPORT PREPARED BY CITY CLERK-TREASURER DELOUGHERTY COVERING DAMAGE ALONG LILAC STREET WITHIN THE MNDOT AND DNR RIGHT-OF-WAY NEAR THE PAUL BUNYAN STATE TRAIL, AND PAVEMENT EDGE CRACKING AND SHOULDER CONCERNS ON SHANTY COURT. AN ESTIMATE FROM SCHRUPP EXCAVATING (ESTIMATE #2026-254, DATED MAY 6, 2026) WAS PRESENTED FOR COUNCIL REVIEW, TOTALING **\$1,310.00**, COVERING THE FOLLOWING SCOPE:

- FIXING INNER CORNERS ON SHANTY COURT (CLASS 1 AGGREGATE, WITH AN OPTION FOR CRUSHED CONCRETE): \$120.00–\$240.00
- SHANTY COURT CUL-DE-SAC (CLASS 1 AGGREGATE, SKID STEER, BROOM ATTACHMENT): \$470.00
- FIXING DAMAGE ALONG VETERANS STREET (CLASS 1 AGGREGATE, SKID STEER): \$480.00

MOTION TO APPROVE THE SCHRUPP EXCAVATING ESTIMATE FOR ROADWAY REPAIRS WAS MADE BY FLATEGRAFF AND SECONDED BY SILTMAN. MOTION CARRIED.

NEW BUSINESS

PAUL BUNYAN SCENIC BYWAY LETTER

THE COUNCIL RECEIVED A LETTER FROM LYNN SCHARENBOICH OF THE PAUL BUNYAN SCENIC BYWAY ASSOCIATION (PBSBA) PROVIDING AN ANNUAL ACTIVITY UPDATE. ITEMS OF NOTE INCLUDED THE START OF THE LINDA ULLAND MEMORIAL GARDENS RESTORATION (A \$65,000 PROJECT), THE ONGOING MULTI-YEAR VIDEO PROJECT (WITH JENKINS AND IDEAL TOWNSHIP VIDEOS COMPLETED), AND THE ANNUAL DINNER AND MEETING SCHEDULED FOR WEDNESDAY, NOVEMBER 11, 2026, AT BITES PUB AND GRUB IN PINE RIVER FROM 5:30–8:00 PM. THE LETTER ALSO INCLUDED THE 2026 SUPPORT DRIVE MATERIALS. NO FORMAL ACTION WAS REQUIRED.

REPORTS OF OFFICERS, COMMITTEES, STAFF

MAYOR'S REPORT

PEQUOT LAKES DAY OF CARING WAS MAY 6TH. MAYOR RUDLANG WORKED WITH STUDENTS ON THE GATEWAY GAZEBO AT A-PINE TO PRESSURE WASH AND REMOVE STAIN. MAYOR RUDLANG NOTED THE WEATHER WAS NOT IDEAL, BUT THAT THE A-PINE SERVED STUDENTS LUNCH AND IT WAS AN OVERALL SUCCESSFUL DAY OF CARING. THE COUNCIL THANKS THE PEQUOT LAKES STUDENTS AND ADMIN FOR THEIR PARTICIPATION.

CLERK'S REPORT

DELOUGHERTY INFORMED THE COUNCIL OF AN ESTIMATE RECEIVED FROM TRUGREEN FOR ANNUAL FERTILIZER APPLICATION AND SHARED THE RESULTS. THE BACKPACK SPRAYER USED BY PUBLIC WORKS NEEDS TO BE REPLAED. DELOUGHERTY ASKED IF SHE SHOULD PURCHASE A NEW SPRAYER FOR AROUND \$100 OR PURCHASE ONE WITH A WARRANTY FOR \$350. COUNCIL CONSENSUS WAS TO PURCHASE THE LESS EXPENSIVE SPRAYER AND HOPE TO APPLY FOR A GRANT THROUGH THE SUMMER THAT WOULD INCLUDE A REQUEST FOR FUNDING OF A LONGER-LASTING SPRAYER.

DELOUGHERTY ALSO SHARED WITH THE COUNCIL THAT THE CITY WAS NOT AWARDED EITHER THE SOURCEWELL COMMUNITY BENEFIT GRANT OR THE AARP COMMUNITY CHALLENGE GRANT. THE COUNCIL THANKED DELOUGHERTY FOR HER EFFORTS IN THE GRANT RESEARCH AND WRITING PROCESS.

DELOUGHERTY INFORMED THE COUNCIL THAT SHE PLANS TO HEAR FROM MANAGEMENT OF NORTHDAL OIL REGARDING THE ROCK ISLAND AND ROAD ACCESS CONCERNS THIS WEEK AND WILL REPORT BACK AT THE NEXT COUNCIL MEETING.

PARKS REPORT

COUNCILMEMBER SILTMAN REQUESTED THAT SAFETY SURFACE CHIPS BE ORDERED FOR THE PLAYGROUND.

MISC./COMMUNICATION

SILTMAN REQUESTED CLARIFICATION ON WHETHER THE CITY PLANS TO SELL THE TWO OLD LAPTOPS OR KEEP THEM ON HAND.

MOTION TO SELL OLD LAPTOPS MADE BY BARNETT, SECONDED BY FLATEGRAFF. MOTION PASSED.

§ 150.283 CONDITIONAL USE PERMITS.

(A) ANY USE LISTED AS A CONDITIONAL USE IN THIS CHAPTER SHALL BE PERMITTED ONLY UPON APPLICATION TO THE ZONING ADMINISTRATOR, PUBLIC HEARING REVIEW AND RECOMMENDATION OF THE PLANNING COMMISSION, AND APPROVAL AND ISSUANCE OF A CONDITIONAL USE PERMIT BY THE CITY COUNCIL.

(B) ALL APPLICATIONS FOR A CONDITIONAL USE PERMIT SHALL BE SUBMITTED TO THE ZONING ADMINISTRATOR 30 DAYS AHEAD OF THE HEARING DATE, ACCOMPANIED BY A CERTIFICATE OF SURVEY (UNLESS WAIVED BY THE ZONING ADMINISTRATOR) SHOWING THE DETAILS OF THE PROPOSAL AND AN ACCURATE LEGAL DESCRIPTION, ALONG WITH THE APPROPRIATE FEE. THE FEE OR CONTRACT OWNER OF THE PROPERTY SHALL SIGN THE APPLICATION. THE ZONING ADMINISTRATOR SHALL NOTIFY ALL PROPERTY OWNERS WITHIN A MINIMUM OF 350 FEET BY REGULAR MAIL AND SHALL ADVERTISE THE HEARING ONCE IN THE LEGAL SECTION OF THE OFFICIAL NEWSPAPER AT LEAST TEN DAYS AHEAD OF THE PUBLIC HEARING. THE ZONING ADMINISTRATOR SHALL SEND THE SAME NOTICE TEN DAYS IN ADVANCE OF THIS HEARING TO THE DNR IF THE PROPOSED IS IN SHORELAND. AT THE APPLICANT'S OPTION, THE APPLICANT MAY REQUEST A SKETCH PLAN REVIEW WITH NO ACTION BY THE PLANNING COMMISSION AND WITH NO FEE BY GIVING 14 DAYS' NOTICE THEREOF TO THE ZONING ADMINISTRATOR, MEETING TIME PERMITTED.

(C) THE APPLICANT SHALL COMPLETE THE CONDITIONAL USE PERMIT APPLICATION APPROVED BY THE CITY COUNCIL. THE APPLICATION SHALL CONTAIN SUBMITTAL REQUIREMENTS, CRITERIA FOR APPROVAL, PROCEDURE FOR CONSIDERATION, AND CITY CONTACT INFORMATION. THE CITY SHALL NOT ACCEPT APPLICATIONS WHERE THE APPLICANT HAS PAST DUE FEES OR CHARGES DUE TO THE CITY UNTIL THE ACCOUNT IS MADE CURRENT.

(D) IN PERMITTING A NEW CONDITIONAL USE OR ALTERATION OF AN EXISTING CONDITIONAL USE, THE PLANNING COMMISSION MAY IMPOSE, IN ADDITION TO THE STANDARDS AND REQUIREMENTS EXPRESSLY SPECIFIED BY THIS CHAPTER, ADDITIONAL CONDITIONS THAT THE

(1) THE FOLLOWING MUST BE MET.

- (A) THE USE OR DEVELOPMENT IS AN APPROPRIATE CONDITIONAL USE IN THE LAND USE ZONE.
- (B) THE USE OR DEVELOPMENT, WITH CONDITIONS, CONFORMS TO THE COMPREHENSIVE LAND USE PLAN.
- (C) THE USE, WITH CONDITIONS, IS COMPATIBLE WITH THE EXISTING NEIGHBORHOOD.
- (D) THE USE, WITH CONDITIONS, WOULD NOT BE INJURIOUS TO THE PUBLIC HEALTH, SAFETY, WELFARE, DECENCY, ORDER, COMFORT, CONVENIENCE, APPEARANCE, OR PROSPERITY OF THE CITY.

(2) THE FOLLOWING MUST BE CONSIDERED.

- (A) THE CONDITIONAL USE SHOULD NOT BE INJURIOUS TO THE USE AND ENJOYMENT OF OTHER PROPERTY IN THE IMMEDIATE VICINITY FOR THE PURPOSE PERMITTED ON THAT PROPERTY, NOR SUBSTANTIALLY DIMINISH OR IMPAIR VALUES IN THE IMMEDIATE VICINITY.
- (B) THE CONDITIONAL USE WILL NOT IMPEDE THE NORMAL AND ORDERLY DEVELOPMENT AND IMPROVEMENT OF SURROUNDING VACANT PROPERTY FOR USES PREDOMINANT IN THE AREA.
- (C) THE CONDITIONAL REQUIREMENTS AT PUBLIC COST FOR PUBLIC FACILITIES AND SERVICES AND WILL NOT BE DETRIMENTAL TO THE ECONOMIC WELFARE OF THE COMMUNITY.
- (D) THE CONDITIONAL USE WILL HAVE VEHICULAR APPROACHES TO THE PROPERTY WHICH ARE SO DESIGNED AS NOT TO CREATE TRAFFIC CONGESTION OR AN INDIFFERENCE WITH TRAFFIC ON SURROUNDING PUBLIC THOROUGHFARES.

CONTROL OFFENSIVE ODOR, FUMES, DUST, NOISE, AND VIBRATION, SO NONE OF THESE WILL CONSTITUTE A NUISANCE AND TO CONTROL LIGHTS AND SIGNS IN SUCH A MANNER THAT NO DISTURBANCE TO NEIGHBORING PROPERTIES WILL RESULT.

(G) THE CONDITIONAL USE WILL NOT RESULT IN THE DESTRUCTION, LOSS, OR DAMAGE OF A NATURAL, SCENIC, OR HISTORICAL FEATURE OF MAJOR SIGNIFICANCE.

SUCH EXPENSES MAY INCLUDE, BUT ARE NOT LIMITED TO, PAYROLL, MAILING COSTS, CONSULTANT FEES, AND OTHER PROFESSIONAL SERVICES THE CITY MAY NEED TO RETAIN IN REVIEWING PERMITS.

(G) CONDITIONAL USE PERMITS MAY BE TRANSFERABLE WHERE REQUESTED BY AN APPLICANT AND APPROVED BY THE PLANNING COMMISSION.

(H) VIOLATIONS OF THE CONDITIONS OF A CONDITIONAL USE PERMIT SHALL AUTOMATICALLY SUSPEND THE PERMIT. A REVIEW OF THE VIOLATION SHALL BE CONDUCTED BY THE PLANNING COMMISSION. THE PLANNING COMMISSION SHALL DETERMINE CONDITIONS FOR REINSTATING THE PERMIT OR REVOCATION, IF APPLICABLE.

(I) FAILURE BY THE OWNER TO ACT ON A CONDITIONAL USE PERMIT WITHIN 12 MONTHS, OR FAILURE TO COMPLETE THE WORK UNDER A CONDITIONAL USE PERMIT WITHIN TWO YEARS, UNLESS EXTENDED BY THE PLANNING COMMISSION, SHALL VOID THE PERMIT. A SECOND EXTENSION SHALL REQUIRE A NEW PUBLIC HEARING. THIS PROVISION SHALL APPLY TO ANY CONDITIONAL USE PERMIT OUTSTANDING AT THE TIME OF THE ADOPTION OF THIS CHAPTER.

(J) ALL USES THAT CEASE OPERATION FOR A PERIOD OF MORE THAN SIX CONSECUTIVE MONTHS SHALL BE DEEMED TO BE DISCONTINUED, AND THE USE PERMIT ESTABLISHING SAID USE SHALL BECOME NULL AND VOID. REESTABLISHMENT OF SAID USE SHALL ONLY BE PERMITTED UPON OBTAINING A NEW CONDITIONAL USE PERMIT.

(K) APPEALS FROM THE ACTION OF THE CITY SHALL BE FILED WITH DISTRICT COURT WITHIN 30 DAYS AFTER CITY COUNCIL ACTION.

(L) THE CONDITIONAL USE PERMIT SHALL BE FILED WITH THE COUNTY RECORDER WITHIN 45 DAYS. THE APPLICANT NEED NOT WAIT FOR FILING TO PROCEED.

REPORT: THE PLANNING COMMISSION REVIEWED THE CITY'S CURRENT DEFINITIONS AND LAND-USE CLASSIFICATIONS FOR **WAREHOUSING** AND **STORAGE**. STAFF HAVE IDENTIFIED INCONSISTENCIES BETWEEN THE DEFINITIONS AND THE LAND USE MATRIX THAT MAY LEAD TO CONFUSION DURING PROJECT REVIEW, ZONING INTERPRETATION, AND ENFORCEMENT. STAFF REQUESTED DIRECTION FROM THE PLANNING COMMISSION ON WHETHER AMENDMENTS SHOULD BE DRAFTED TO CLARIFY AND ALIGN THESE TERMS.

THE CITY'S ZONING ORDINANCE INCLUDES SEPARATE DEFINITIONS AND LAND-USE CLASSIFICATIONS FOR WAREHOUSING AND STORAGE, WHICH APPEAR IN MULTIPLE ZONING DISTRICTS. THESE USES ARE OFTEN RELATED BUT NOT IDENTICAL. OVER TIME, STAFF HAVE ENCOUNTERED SITUATIONS WHERE APPLICANTS, PROPERTY OWNERS, AND EVEN REVIEWING BODIES INTERPRET THESE TERMS DIFFERENTLY.

THESE INCONSISTENCIES CAN LEAD TO UNPREDICTABLE OUTCOMES AND DIFFICULTY APPLYING THE LAND USE MATRIX CONSISTENTLY.

THE PURPOSE OF THIS REVIEW WAS TO ENSURE THAT THE DEFINITIONS AND LAND-USE CLASSIFICATIONS CLEARLY REFLECT THE CITY'S INTENT AND SUPPORT CONSISTENT APPLICATION ACROSS ZONING DISTRICTS.

WAREHOUSING. The principal use is the storage of materials or equipment within an enclosed building.

WAREHOUSING, COMMERCIAL. The rental or sale of **warehousing** space.
